Pursuant to C.G.S. Section 3-37(b), please find attached the monthly report for April 2013, which provides certain information regarding the State's cash position and bonding.

While the report for April 2013 reflects adequate-to-strong overall cash balances, we conducted transfers between bond proceeds investment accounts and the common cash pool during the first half of the month. During the latter half of April, the common cash pool balances grew strongly, ending the month nearly \$200 million above the level of a year ago. Common cash pool balances remained comparatively good during May, and no transfers were conducted during the month.

I will keep you updated on these cash flow issues. In the meantime, should you have any questions, please feel free to call on me.
